Our Programs and Services

Housing

Emergency Shelter - The shelter is open 24/7/365. Focusing on family reunification whenever safe and possible, the Emergency Shelter provides temporary safe shelter for up to 30 days, paired with supportive services tailored to youth and family needs.

Transitions - Sometimes reunifying with family takes some time. Or, returning home simply isn't an option. The Transitions program offers a safe and supportive environment for young people ages 16 and 17 for up to 18 months—time to work through issues, plan next steps and build new skills for independence.

Rita's House - Our property at 2200 Emerson Avenue has been renovated and re-opened to provide rental housing in an intentional community for 18 to 21-year-old youth. While living in the house, young people learn independent living skills, work with a case manager, and build a rental history.

Youth Response Center

Crisis phone and text lines are staffed 24/7/365 by staff and volunteers trained to de-escalate crises, provide support and connect youth and families with resources. We also host YSNMN.org, a mobile app connecting youth with available shelter and resources in real time.



In 2017, Rita's House was restored and renovated. In 2018, we're excited to welcome the first tenants.

Outreach and Support

Outreach and Support - Our Outreach team connects with youth, offers educational presentations and is a presence at community events to promote awareness of our services and resources.

Weekly Support Groups -Community helps youth stay on track with their goals. The Bridge offers support groups for crime victims, LGBTQ youth, work readiness, and more.

Work Ambassador - Youth have the opportunity to learn on the job. Staff help young people develop resumes and practice interview skills, then build hands-on work experience and job history.

Juvenile Detention Alternatives
Initiative - Rather than
spend time in jail, first-time
juvenile offenders stay in the
Emergency Shelter while
awaiting their scheduled
court day. Youth explore
new strategies and set goals
to move forward in positive
directions while receiving
counseling and support.

Hennepin County 365 - This program serves youth who are ready to live on their own. Case managers support youth as they transition to living independently, including advising on money management, identifying affordable apartments, and interpreting lease requirements.

2017 Snapshot

By the Numbers

Here's a re-cap of the year:

- Provided emergency shelter and supportive housing to 698 unduplicated youth.
- Responded to 2,511 crisis calls and 9,171 texts.
- Provided 658 youth and family counseling and therapy sessions.
- Offered shelter, case management and legal resources for 95 systems-involved (juvenile justice, foster care or child protection) youth.
- Provided support group sessions with 2,219 attendances.

When they left The Bridge...

- 73% of youth exited to safe and stable housing.
- 68% of youth made safer decisions.
- 67% identified at least one positive connection with a peer or caring adult.
- 73% were connected to health care.
- 55% reported a better relationship with family.
- 72% were attending school regularly.
- 69% had increased their life skills






Last summer, we enjoyed marching in the Pride parade alongside the Hyatt. We support all youth regardless of race, disability, or sexuality.







Whitney's mother was an addict, and Whitney ran away multiple times in her early teens because it wasn't safe to stay at home. During one of those periods, she found her way to The Bridge. Counseling helped her return home, but the stability didn't last.

Finally, she realized she had to move out in order to move forward in her own life. That's when she found her way to Transitions.

"The Bridge was a haven for my safety and growth when I was in high school," she said.

Whitney spent parts of her junior and senior year living at The Bridge, where she received counseling for trauma and depression. In Transitions, she found a safe place where she could learn how to take care of herself and work toward her goals. She still remembers the day she received her acceptance letter to Augsburg College.

"Everyone was freaking out with me," she said. "It was really beautiful, it felt like I had been accepted into a family outside of my blood."

She graduated with a double major in Creative Writing and Sociology, and a minor in Social Welfare. She started working part time at Penumbra Theatre after graduating, and has worked her way up in the past 2.5 years to Executive Assistant.

"It's taken a lot to get here. I have a lot of lumps and the scars to show for it," Whitney said. "But looking at where I am, I'm proud of what I've been able to overcome."
